## Legislative News

Here is a summary of 2008 Kansas Senate and House bills I think are related to our work:

**\$5 Mailing Fee OK-** SB 366: Allows district and municipal courts to charge a \$5 court cost for mailing a letter to the defendant that failure to comply will result in the suspension of their driver's license. Also makes some changes in the district court summons regarding notice to a violator about the potential suspension for failing to comply. (Effective date 07-01-08)

**Micro Utility Tucks** - SB 2119: Provides the statutory provisions for micro utility trucks (new vehicle class). They cannot be operated on the state and federal highways. They can be operated on city streets or highways only with the city's authorization. Cannot be registered, but are to be titled for non-highway use. (Effective date 07-01-08)

**MDMA Penalties** - HB 2545: Increasing penalties for possession of MDMA (the hallucinogenic drug commonly known as ecstasy). It will make MDMA penalties the same as marijuana. (Effective date 07-01-08)

**Auto Accident = Drug Test** - HB 2617: Changes KSA 8-1001 sect (b) so that when a person is a driver of a vehicle involved in an accident resulting in serious injury or death,

testing for alcohol/drugs must be requested. Also addresses many of the problems with cooperation between law enforcement and medical staff regarding blood sample collection for DUI cases. (Effective 07-01-08)

**No Old Front Tags** - HB 2622: Prohibits old tags on the front of vehicles if the vehicle is registered in Kansas (except large trucks and antique cars). (Effective 07-01-08)

**Gold Star License Plates** - HB 2691: Creates Gold Star Family license plates for mothers of soldiers who died on active military duty and in good standing. (Effective 07-01-08)

**In God We Trust Plate** - HB 2704: Creates an "In God We Trust" registration plate. (Effective 07-01-08)

**Domestic Battery, Animal Cruelty...** - HB 2780: Complex bill with a variety of provisions. Increases penalties for domestic battery and certain types of animal cruelty; prohibits expungement of conviction for aggravated endangering a child; adds Heart of America Regional Computer Forensics Lab to agencies eligible for \$400 analysis fee from persons convicted. (Effective 07-01-08)

## DMV Electronic Reporting - Traffic Violations

Setting up for electronic reporting involves some careful work connecting the dots between local provisions, KSA equivalents, and the correct DMV codes. It can be very easy to make errors in how offenses are coded. Below is a table of some common STO offenses as they are coded for electronic reporting.

This table has been reviewed by a couple courts and should be quite accurate, but we are all human... If you feel any corrections need to be made, please report them.

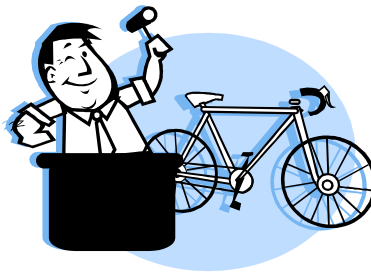

DARWIN, Australia (AP) -- An Australian driver who secured a carton of beer in his car with a seat belt but left a 5-year-old child unrestrained was fined 750 Australian dollars (\$710; €460), police said Tuesday.

Constable Wayne Burnett said he was "shocked and appalled" when he pulled over the unregistered car on Friday in the central Australian town of Alice Springs.

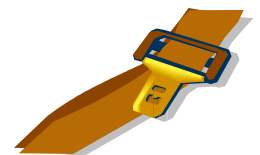
The 30-can carton was strapped in between the two adults sitting in the back seat of the car. The child was also in back, on the vehicle's floor.

"The child was sitting in the lump in the center, unrestrained," Burnett told reporters Tuesday.

The driver was fined for driving an unregistered and uninsured vehicle, and for failing to ensure a child was wearing a seat belt.
